Minutes of the 34<sup>nd</sup> Annual General Meeting

Online Zoom Meeting

Ronald Charlemagne chaired the meeting and Clement Kent welcomed members arriving on Zoom.  Barbara O'Malley and Eleonora Schmied represented the OHA.
1. Call to Order: Ron Charlemagne called the meeting to order at 7:11 p.m. Ron Charlemagne spoke the Land Acknowledgement, and welcomed Barbara O'Malley and Eleonora Schmied from District 15, Ontario Horticultural Association.
<b>2. Report on Quorum:</b> The number of members present online was counted by visible names signed in to Zoom and confirmed that they were current members. At 20 members quorum was confirmed.

5. President's Report — Ron Charlemagne:
Ron thanked everyone and acknowledged the honour of being president.
He opened his report with thanks to everyone at the Hort, volunteers, participants and supporters. Many activities were continued this year, even with the limitations imposed by COVID 19. Our online speaker nights continued, education and outreach efforts included West Toronto KEYS-To-INclusion and presentations to George Brown College students, the Plant Share was a success, we funded community garden projects, and Project Swallowtail continues to grow. He closed with encouraging us to think of the coming year as a challenge to 'adapt and respond'.

# 6. Treasurer's Report - Emieke Geldof:

This has been a good year. The Hort profit is just under \$400.00. The Ontario government supported horticultural societies this year, as many were struggling. Normal funding was \$1000.00; this year we received \$2100.00. The Plant Share made 1600.00. We gave out \$4000.00 to community gardens and we funded three new community gardens. In summary, we had total income of \$8,101.60, total expenses of \$7,721.83, leaving a profit of \$379.77. Membership went up from 131 to 180 members.

The financial details were mounted on screen while Emieke spoke.

Thank you to this year's financial reviewers Ann Wong and Mary Mosser, who reviewed the financials for the year of October 1, 2019 through to September 31, 2020.

**Appointment of Financial Auditors:** Patty McKnight and Ingrid Whittaker have kindly agreed to be next year's financial reviewers and will therefore be reviewing the financial statements from October 1, 2021 through to September 31, 2022 once completed.

# Acceptance of the Treasurer's Report and the reviewed financials for the year of October 1, 2020 through to September 31, 2021:

Ron Charlemagne moved to approve the Financial Report and was seconded by Bill Cheng. Carried. No virtual hands were raised in opposition.

### 7. Vote on the amendment to the Constitution:

The text for the amendment was printed in the last Bulletin. (See below.) The wording allows in-person meetings or online (Zoom) meetings that provide the opportunity for members to hear, voice their opinions and vote. This would also allow for 'hybrid' meetings that would be a combination of in-person and online. During the discussion the wording of the motion was posted to the Chat feature for all to see.
